The current Renew 22 Expansion request lists this under "ongoing" expansion for \$815,000. Which of the below items were removed from the original list? Expansion request #31 is for \$875,000 for "Renew '22 initiatives". What would be funded by that allocation?

The cost of conducting public opinion polling for a general purpose sales tax measure (\$60,000) was removed from the original list as the Board did not express support for the general purpose sales tax initiative during Budget Workshop. With the removal of that cost, the revised expansion request is \$815,000.

This expansion request is an ongoing request to help cover the anticipated costs of implementing Renew '22 initiatives over the remaining four-year period. A significant cost component of Renew '22 is conducting department management audits, which is estimated to be \$600,000 per year over four years. Under the current plan, the County would hire external consultant(s) to audit a set of departments each year over four years. The balance of the expansion request would be used to cover other costs associated with implementing other initiatives, many of which involve the enhancement of current technology or the procurement of new technology and consolidation or centralization of functions that span or impact multiple departments.
