**RE: AB 310 (Santiago) California Infrastructure and Economic Development Bank - Support**

Dear Senator McGuire:

On behalf of the County of Santa Barbara Board of Supervisors, I write to state our support for AB 310 (Santiago), which would establish the Infrastructure and Economic Development Bank Commission and place the I-Bank under the supervision of the commission. The bill would require that the commission be comprised of the Governor, the Treasurer, the Controller, or their designees. The bill would require the commission to appoint members of the bank board, as specified and would eliminate the I-Bank Fund spending limit with respect to educational facilities, environmental mitigation measures, and parks and recreational facilities.

The Board of Supervisors adopted a 2020 Legislative Platform that includes the Efficient Service Delivery and Operations Legislative Principle that specifically states that the County will support operational enhancements relevant to the County's mission and services.
