If the claim is rejected by the County Treasurer, the party who submitted the claim may file a verified complaint seeking to recover all, or a designated part, of the money in a court of competent jurisdiction within the County of Santa Barbara, and copy thereof, together with the summons issued thereon, and within 30 days from notice of rejection, shall be served upon the County Treasurer, 105 East Anapamu St., Room 109, Santa Barbara, CA, in accordance with Government Code Section 50052.
