Meeting Minutes

1. **Call-to-Order and Roll-Call** – Chair Byrne called the meeting to order at 3:04 p.m. Lucero Garcia conducted roll-call.
2. **Establish Quorum** – Chair Byrne established quorum.
3. **General Public Comment** – Ruth Ackerman announced she will be re-appointed to the BWC.
4. **Welcome and Introductions** – Chair Byrne welcomed everyone followed by self-introductions.
5. **Chairperson Announcements** – Chair Byrne had no announcements.
6. **Review and Approve Minutes of the June 20, 2018 BWC Meeting** (Attachment 6a) –

Action: Commissioner Truman made a motion to approve the June 20, 2018 BWC meeting minutes as presented. Commissioner Huffines seconded. No objections. Motion carried.

7. **Executive Director's Report** - Department Director, Alice Gleghorn covered the following: Santa Maria Adult Outpatient Clinic has 5 Dialectical Behavioral Therapy (DBT) graduates; Lompoc Children and Transitional Age Youth (TAY) teams celebrate success of completing and finalizing documentations before the end of FY 17-18; Timeliness self-assessment demonstrates improvements in access to care; Crisis Services (formerly the CARES and Triage teams) are located at 315 Camino del Remedio; the Children's Triage Grant will be placed on hold due to the Governor's amended budget effecting MHSA funding; July is Minority Mental Health Month; Mixtec Culture Training available on Relias; National and Statewide news included as well as the Systems Change Calendar.

New Business

8. **CPS Discussion** (Attachments 8a, 8b) – Ms. Khatapoush discussed the CPS data and reviewed 8 domain questions selected for the consumer surveys. Vice Chair Moore asked if there are goals or a baseline to compare the data results. Dr. Gleghorn indicated the D-pages set the Department's goals and the data provided does demonstrate consumer satisfaction has improved. Dr. Gleghorn added the perception of cultural sensitivity is higher in Santa Barbara County than the State of California. Ms. Khatapoush read comments made by adults, youth, and youth family and answered Commissioner questions.
9. **Updated Goals Discussion** – Vice Chair Moore would like the commissioners to provide goals and/or any matters that need to be addressed. Site visits are encouraged as that is a way to be engaged on behalf of the community. Commissioner Eldridge commented communication is important to completing goals. Commissioner Pearson reiterated having site visit data implemented. Commissioner Winter would like to review the Bylaws for inconsistencies and will ask Commissioner Rumberger to assist. Vice Chair Moore suggested creating an ad hoc subcommittee for this task. The BWC and Dr. Gleghorn were commended for their participation and having appointed staff attend this monthly meeting.
10. **Reports of Officers, Boards: Chair, Site Visits, Liaisons to other Committees and BWC Special Committees**
 - A. **BWC Site Review Compilation Ad Hoc Sub-committee Update** – Commissioner Pearson indicated the group has a list of sites to visit and a questionnaire to fill-in while touring. Commissioner Pearson suggested having commissioners work in different districts with different members and would like the data from the site questionnaire gathered and reported.
 - B. **Sheriff's Community Corrections Input Group Update** – Commissioner Richardson shared she volunteered Saturday assisting Spanish speaking families and the Sheriff's office agreed to meet with those families with any concerns they may have in North and South County. This meeting is for community members to meet once a month to discuss jail matters with the Sheriff's Department Chair.
 - C. **Ballot Initiative Exploration Ad Hoc Sub-committee** – Chair Byrne described the group is observing the proposed tax rates. The suggestion for Santa Barbara County is a 1 percent increase. To have this proposal in the year 2020 ballot there may be a need of collecting signatures. This tax increase can potentially assist filling in the gaps for behavioral health in the County.
