The undersigned is informed and believes that:

COUNT 1

On or about May 18, 2016, in the County of Santa Barbara, the crime of DRIVING UNDER THE INFLUENCE OF ALCOHOL CAUSING INJURY, in violation of **VEHICLE CODE SECTION 23153(a)**, a Felony, was committed by JENSEN BUCHANAN, who did unlawfully, while under the influence of an alcoholic beverage drive a vehicle and in so driving, concurrently did an act forbidden by law and neglected a duty imposed by law, to wit: a violation of Vehicle Code Section 21651(b), which proximately caused bodily injury to BRADLEY GALE ASOLAS.

"NOTICE: If convicted of this offense the court must suspend your driving privileges if you are under the age of 21 years. Vehicle Code Section 13202.5".

SPEC ALLEG - OVER .15% BLOOD ALCOHOL

It is further alleged AS TO COUNTS 1 and 2 that the defendant had a blood alcohol content of .15 percent and higher within the meaning of Vehicle Code section 23578.

SPECIAL ALLEG - GREAT BODILY INJURY

It is further alleged AS TO COUNTS 1 and 2 that in the commission of the above offense the said defendant, JENSEN BUCHANAN, personally inflicted great bodily injury on BRADLEY GALE ASOLAS, not on an accomplice to the above offense, within the meaning of **Penal Code Section 12022.7(a)** and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8).

It is further alleged that the above offense is a violent felony within the meaning of **Penal Code Section 667.5(c)(8)**.

COUNT 2

On or about May 18, 2016, in the County of Santa Barbara, the crime of DRIVING WITH A .08% BLOOD ALCOHOL CAUSING INJURY, in violation of VEHICLE CODE SECTION 23153(b), a Felony, was committed by JENSEN BUCHANAN, who did unlawfully while having .08 percent and more, by weight, of alcohol in his/her blood, drive a vehicle and in so driving did an act forbidden by law, and neglected a duty imposed by law, to wit: a violation of Vehicle Code Section 21651(b) which proximately caused bodily injury to BRADLEY GALE ASOLAS.

“NOTICE: If convicted of this offense the court must suspend your driving privileges if you are under the age of 21 years. Vehicle Code Section 13202.5.”

Pursuant to Penal Code Section 1054.5(b), the People are hereby informally requesting that defense counsel provide discovery to the People as required by Penal Code Section 1054.3.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT AND THAT THIS COMPLAINT CONSISTS OF 2 COUNT(S).
