The undersigned is informed and believes that:

COUNT 1

On or about February 9, 2020, in the County of Santa Barbara, the crime of GROSS VEHICULAR MANSLAUGHTER WHILE INTOXICATED, in violation of **PENAL CODE SECTION 191.5(a)**, a Felony, was committed by ERIC MAURICIO RAMIREZ-AGUILAR, who did unlawfully kill ADOLFO CORRAL, a human being, without malice aforethought, in the driving of a vehicle in violation of Vehicle Code Sections 23140, 23152 and 23153 and the killing was proximate result of the commission of an unlawful act, not amounting to a felony and with gross negligence and/or proximate result of the commission of a lawful act which might produce death, in an unlawful manner, and with gross negligence and/or proximate result of the commission of an unlawful act, not amounting to a felony, and with gross negligence and the proximate result of the commission of lawful act which might produce death, in an unlawful manner, and with gross negligence.

It is further alleged that the above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) (8).

SPEC ALLEG-FLEEING THE SCENE OF THE CRIME

It is further alleged pursuant to **Vehicle Code section 20001(c)** that after committing the above offense, the defendant fled the scene of the crime.

SPEC ALLEG-BODILY INJURY TO MORE THAN ONE VICTIM

It is further alleged that the defendant proximately caused death or bodily injury to more than one victim, to wit: ADOLFO CORRAL and MARY JANE BECERRA CORRAL, within the meaning of **Vehicle Code Section 23558**.

COUNT 2

On or about February 9, 2020, in the County of Santa Barbara, the crime of GROSS VEHICULAR MANSLAUGHTER WHILE INTOXICATED, in violation of **PENAL CODE SECTION 191.5(a)**, a Felony, was committed by ERIC MAURICIO RAMIREZ-AGUILAR, who did unlawfully kill MARY JANE BECERRA CORRAL, a human being, without malice aforethought, in the driving of a vehicle in violation of Vehicle Code Sections 23140, 23152 and 23153 and the killing was proximate result of the commission of an unlawful act, not amounting to a felony and with gross negligence and/or proximate result of the commission of a lawful act which might produce death, in an unlawful manner, and with gross negligence and/or proximate result of the commission of an unlawful act, not amounting to a felony, and with gross negligence and the proximate result of the commission of lawful act which might produce death, in an unlawful manner, and with gross negligence.

SPEC ALLEG-BODILY INJURY TO MORE THAN ONE VICTIM

It is further alleged that the defendant proximately caused death or bodily injury to more than one victim, to wit: ADOLFO CORRAL and MARY JANE BECERRA CORRAL, within the meaning of **Vehicle Code Section 23558**.

COUNT 3

On or about February 9, 2020, in the County of Santa Barbara, the crime of LEAVING THE SCENE OF AN ACCIDENT THAT RESULTED IN DEATH OR SERIOUS PERMANENT INJURY, in violation of **VEHICLE CODE SECTION 20001(b)(2)**, a Felony, was committed by ERIC MAURICIO RAMIREZ-AGUILAR, who did unlawfully, and knowingly, being a driver of a vehicle involved in an accident resulting in death or serious bodily injury to a person other than himself, fail, refuse, or neglect to give to the injured person or to a traffic police officer at the scene of the accident his name and address, the registration number of his vehicle, and the name of the owner of said vehicle; to exhibit his operator's license; to render reasonable assistance to the injured person; and perform the duties specified in Vehicle Code Sections 20003 and 20004.

COUNT 4

On or about February 9, 2020, in the County of Santa Barbara, the crime of DRIVING UNDER THE INFLUENCE OF ALCOHOL CAUSING INJURY, in violation of **VEHICLE CODE SECTION 23153(a)**, a Felony, was committed by ERIC MAURICIO RAMIREZ-AGUILAR, who did unlawfully, while under the influence of an alcoholic beverage drive a vehicle and in so driving, concurrently did an act forbidden by law and neglected a duty imposed by law, to wit: a violation of Vehicle Code Section VC23103, which proximately caused bodily injury to ADOLFO CORRAL and MARY JANE BECERRA CORRAL.

"NOTICE: If convicted of this offense the court must suspend your driving privileges if you are under the age of 21 years. Vehicle Code Section 13202.5".

SPECIAL ALLEG - GREAT BODILY INJURY

It is further alleged that in the commission of the above offense the said defendant, ERIC MAURICIO RAMIREZ-AGUILAR, personally inflicted great bodily injury on ADOLFO CORRAL, not an accomplice to the above offense, within the meaning of **Penal Code Section 12022.7(a)** and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8).

It is further alleged that the above offense is a violent felony within the meaning of **Penal Code Section 667.5(c)(8)**.

SPECIAL ALLEG - GREAT BODILY INJURY

It is further alleged that in the commission of the above offense the said defendant, ERIC MAURICIO RAMIREZ-AGUILAR, personally inflicted great bodily injury on MARY JANE BECERRA CORRAL, not an accomplice to the above offense, within the meaning of **Penal Code Section 12022.7(a)** and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8).

It is further alleged that the above offense is a violent felony within the meaning of **Penal Code Section 667.5(c)(8)**.

SPEC ALLEG-BODILY INJURY TO MORE THAN ONE VICTIM

It is further alleged that the defendant proximately caused death or bodily injury to more than one victim, to wit: ADOLFO CORRAL and MARY JANE BECERRA CORRAL, within the meaning of **Vehicle Code Section 23558**.

SPEC ALLEG – SERIOUS/VIOLENT/REGISTERABLE SEX OFFENSE FELONY

It is further alleged as to Count 1, 2 and 4 are serious felonies within the meaning of Penal Code section 1192.7(c) and/or a violent felony described in subdivision(s) of Penal Code section 667.5 and/or an offense requiring registration under the provisions Penal Code sections 290 et seq, pursuant to Penal Code section 1170(h), that the defendant is ineligible for a state prison sentence to be served in the county jail.


“NOTICE: Pursuant to Penal Code section 1170(f), notwithstanding any other provisions of this section, for purposes of subdivision (h) of section 1170, any allegation that a defendant is ineligible for a state prison sentence to be served in the county jail due to a prior or current conviction, or sentence enhancement, or because he or she is required to register as a sex offender, or because the legislature specifically excluded the offense, shall not be subject to dismissal pursuant to §1385 PC.”
